Willow (T5) Remove self set to ground level

Poplar (T6) Remove self set to ground level

Buddleja (T7) Remove to ground level due to damage to property

Mature Beech (T8) Crown raise & reduce crown spread to clear building

Ornamental Plum & Hawthorn (T9) Reduce back to boundary as is growing over pavement
