## Officer Appraisal / Comments:

During the course of the application the material schedule has been amended to include more variety into the development and to include more information on the finishing specifications.

A plan under reference Drg No. 302 Revision P1 has been submitted identifying the plots which use the brick and tile combination specified in the material schedule.

The material schedule does show brick and tile options which does not necessarily correlate with Drg No. 302 Rev P1. However, the drawing does show three brick types and two tile types which demonstrate a variety of materials across the site.

The Agent has however added a preference asking for the Blenheim Red Brick of the four options to be considered.

Taking into account all the information presented it is considered the condition has been satisfied as the scheme would have a variation of finishing materials which would enhance the development.

Given the schedule document includes options it would be difficult to solely use it to satisfy the condition. Instead it is considered expedient to list the materials in the interests of clarity in the decision letter which would be read in conjunction with Drg No. 302 Rev P1.
