Application for works to trees subject to a Tree Preservation Order (Wyberton No. 5) to include:

- T1 - Silver birch 2M reduction and remove a number of branches**
- T3 - Oak tree Reduce by 20%, remove dead wood and reshape**
- T5 - Chestnut tree Reduce by 25%, remove dead wood and reshape**

I refer to the above application, which was received by Boston Borough Council on and gives notice that you wish to undertake the following work as described on your application;

In pursuance of their powers under the above mentioned Act and Regulations, Boston Borough Council as Local Planning Authority, hereby issue a **split decision** for the proposed works.

The Council **GRANTS CONSENT** to carry out the following elements of the proposed tree works:-

- T1 - Silver birch 2M reduction and remove a number of branches
- T3 - Oak tree Reduce by 20%, remove dead wood and reshape



The Council hereby **REFUSE TO GRANT CONSENT** to carry out the following elements of the proposed tree works;

- T5 - Reduce by 25% and reshape for the following reason:

The tree is showing signs of Bleeding Cankor of Horse Chestnut and the pruning of branches would have a negative impact on the resilience of the tree to this disease, impacting its health and longevity.

Unless otherwise stated within the conditions above;

- All works should be completed within two years of the date of this notice.
- This consent only allows for the identified works to be carried out once.
- All works should be carried out in accordance with the British Standard BS 3998:2010 – Tree Work-Recommendations.
