C.3 Works for the investigation of possible floor rot in room P.G-1 (work item 1) shall not proceed beyond the removal of the plywood floor/floorboards until a written survey/scheme of works (prepared by a suitably qualified surveyor) has been submitted to and approved in writing by the Local Planning Authority. That survey/scheme of works shall:	Floor Timber Rot Investigation Report & Repair Method Statement dated April 2023	Acceptable
include a written and photographic assessment of the condition of the floor; identify those elements of the floor that are considered to need repair/replacement, set out a methodology for those works of repair and/or replacement, and identify the significance of any historic fabric affected;		

include a methodology for: the recording of any historic fabric that will be lost; the publication and dissemination of that record; and the archive deposition of that record. The works shall be undertaken in accordance with the approved survey/scheme of works.		
C.5 Prior to the insertion of new softwood mouldings at wall piers and column in rooms P.G-2, P.G-6 and P.G-9 (work item 4) a sample moulding shall be approved in writing by the Local Planning Authority. The works shall thereafter be carried out in accordance with the approved sample.	Dwg. No. 203-306: New Reinstatement Moulding Details	Acceptable
C.6 Prior to the insertion of external flue C (work items 15 and 25), details shall be submitted to and approved in writing by the Local Planning Authority of appropriate repair works to the plaster infill panel to the North Elevation. These repair works shall be carried out in accordance with the approved details within 3 months of their final approval.	Dwg. No. 203-305: 19 th C. Plaster Wall Infill Panel Repair	Acceptable
