I'm not sure what extra information I can give Environmental Health over and above that which I have already given. Did they see my comments in the email or did they only look at the attached form? As I said previously, the biomass boilers are made by Glen Farrow, and one is 175 kw and the other is 210 kw. The fuel used is virgin timber which is generated through the tree surgery business which operates from the site. I have attached some information on Glen Farrow boilers which you may find useful.

In relation to the highway's comments, the pods are clearly for holiday use. The information they are asking for seems a little excessive for such a small development. Usually with this type of accommodation people stay for one or two nights or at most they stay Friday to Monday and then Monday to Friday. They will only be for two people so there will only be one vehicle per unit and I expect most people would only go out and come back once a day.

I have passed on the email and attachment to our Environmental Health Team who have requested further information;

"The applicant has submitted a Waste Exemption Registration Form; however, this does not supply the information requested.

In order to assess any potential impact on air quality we require more information about these boilers, such as the capacity and type of fuel to be used. The applicant should be advised that where waste wood is used as a fuel source they may be required to apply to the Local Authority for a permit

under the Environmental Permitting (England & Wales) Regulations 2016, Schedule 1 - Section 5.1B. Boilers fuelled by virgin timber do not require a permit.

We will comment further on receipt of the information requested."
