## **Highway and Lead Local Flood Authority Report**

Substantive Response provided in accordance with article 22(5) of The Town and Country Planning (Development Management Procedure) (England) Order 2015:

**Recommendation: Refuse** 

The application site is located at the far end of Wide Bargate, which is served by a public footway to the site's frontage with supporting safety railings on the carriageway kerb edge and an inner safety railing where there is a change in footway levels. The footway presently serves nearby amenities and the centre of Boston Town and to premises next door with a similar shop front access. It is not unreasonable to say that this location is subject to high footfall and can be congested due to the proximity of the pedestrian crossing facility located on metres away on Horncastle Road. The provision of the external ramp situated on the adopted highway proposed in this application would unacceptably have an impact and increase the incidence of pedestrians meeting other pedestrians, including those on motorised mobility units, wheelchairs, pushchairs/prams, and more vulnerable users in the vicinity of the ramp, due to the limited width between the ramp and the inner railings, having to take unreasonable manoeuvres in order to pass one another, resulting in the cumulative detrimental impact upon highway safety to all users.

We would suggest that the applicant makes consideration of alternative means of access by alterations internally to facilitate the changes in access layout, due to the heavily constrained location.

The proposed development would therefore fail to provide safe and suitable access for all people and an unacceptable impact upon highway safety, contrary to the guidance provided within the National Planning Policy Framework document, Paragraphs 110 and 111.
