Electricity Act 1989: Overhead Lines (Exemption) (England and Wales) Regulations 2009

NGED propose to undertake the following works set out below which are exempt from requiring Section 37 Consent under the Electricity Act 1989 by falling within The Overhead Lines (Exemption) (England and Wales) Regulations 2009: Regulation 3(1)(e).

NGED intend to carry out the refurbishment of their existing Bicker Fen – Boston 132kV overhead line ('OHL'). This includes the re-wiring of approximately 15.5km of OHL and the installation of ancillary infrastructure, including insulators and conductor fittings across 55 no. towers, all of which fall within Boston Borough Council's administrative area.

In accordance with the July 2014 Guidance Note to the Statutory Consents Regime for Overhead Power Lines in England and Wales under Section 37 of the Electricity Act 1989, the refurbishment of the existing OHL on a "like-for-like" basis would be permitted development and exempt from requiring Section 37 consent as a "design successor".

For works considered exempt under Regulation 3(1)(e), whilst a new consent is not required from central government, as a responsible undertaker, NGED are required to submit a 'simplified Section 37 notification' to the relevant Local Planning Authority. As the proposed development is considered to be exempt under Regulation 3(1)(e) and would constitute a "design successor" as per the above Section 37 Guidance Note, Dalcour Maclaren on behalf of NGED are therefore submitting this Section 37 notification to Boston Borough Council, as the relevant authority.

As per the relevant guidance, the local planning authority should screen notifications and provide a response within **6 weeks** advising if they have no objections or wish to invoke the full section 37 consent process for the proposal. If no response is received within 6 weeks, it is assumed that the Council does not wish to comment/has no objections to the proposed development.

Subject to the Council's agreement, the proposed works are considered to be exempt from required Section 37 Consent by virtue of satisfying the limitations on the exemptions contained in Regulation 3 for the following reasons:

- The proposed development does not fall within a "sensitive area" as defined by the Electricity Works (Environmental Impact Assessment) Regulations 2017;

- There will be no change to the nominal voltage of the overhead line;
- The route of the replacement OHL will not deviate from the existing by more than 60m in accordance with limitation 4(1)(d); and
- All conditions of the original Section 37 Consent will be complied with.

Boston Borough Council is therefore requested to indicate that it has no objection to the work being carried out by returning two copies of this Form with the Certificate completed and signed.
