1 – Horse Chestnut – Fell, due to the fact the tree has major root problems and its visible the tree is dyeing back at a fast rate and has become not a tree to save by reducing in height or other such works.  
I believe the root system is in the process of decay and could give way making the tree extremely unsafe to the property and public also the road as it has grown towards a path and road .  
Under normal circumstances I would ask the customer to re plant but there are plenty of trees on this property and it would not be advisable to do so here.

This is what you sent Dr Weil originally when he contacted the council,  
Dr Weil,

Richard has looked at the trees and has sent me the following comment.

Hi peter

I called to skirbeck gardens last week.

I viewed the trees from the footpath opposite, there are two trees a Horse Chestnut and a Sycamore. The Sycamore is of good condition though it shares a co-dominant crown with the horse chestnut. The horse chestnut is in decline, crown dieback and deadwood is evident. I would suggest there are 2 courses of action, my preferred action is underlined.

- 1 – Horse Chestnut – Fell, Sycamore - crown reduce 4-5m in height.
- 2 – Horse Chestnut – Crown reduce by 25%, Sycamore – No action.

It is up to you which option you prefer. You should refer to this advice from Richard on the form to justify the application.

We are leaving the sycamore trees as to let them fill out fully, Dr Weil dose not want to do unnecessary work or damage the ascetics of the area.
